In the cleaning step the detergent neodisher MediClean forte is recommended.

General instructions on use:

- For professional use only.
- The neodisher Septo DN 2 working solution has to be rinsed off completely with water (preferably deionised water).
 - For avoiding water stains the use of deionised water in the final rinse is recommended.
- Rinse out dosing system including suction hose with water before changing product.
- Please observe the instrument manufacturer's recommendations for reprocessing according to the requirements of DIN EN ISO 17664.
- The instructions given by manufacturer of the washer disinfector are to be observed.
- Do not mix with other products.
